Prorated Bill - If this is on your bill, the current billing period is for less than 26 days or more than 35 days or a rate change occurred during the current billing period.

Service Charge - Charge for opening an account.

Societal Benefits Charge (SBC) - Charge to recover costs of low-income assistance and weather/cation, energy conservation programs, nuclear decommissioning, manufactured gas plant remediation, and consumer education on competition.
